File Manager provides users with the ability to create the metadata required to provision workspaces by making field selections from a firm-approved list and providing a name or description of the workspace. This information is stored in a database and can then be used to automatically generate workspaces just as a matter or project management system would provide.

File Manager consists of two components:

File Manager Snap-in – This administrator tool is used to configure the metadata items presented to the user for selection when requesting a workspace to be provisioned.

File Manager Client – The component installed on end user machines that allows them to access the *File Manager* menu.

- Allows designated end-users to provision the data that can be used to generate workspaces.
- End-users simply have to select metadata from a firm-approved list and provide a workspace name. A separate workspace generation task can then be used to generate the workspace with the information chosen by the end-user.
- Can act as a matter or project management system for those firms that do not have central billing or management system, or wish to generate workspaces that are not based on standard fields, such as administrative or departmental workspaces.

File Manager is an RBRO WorkSite System Manager (WSM) snap-in. The RBRO WorkSite System Manager is a proprietary enterprise administration solution that allows organizations to gain a greater degree of control over their iManage Work system through a single source. It is provided at no charge with the purchase of File Manager or other snap-in tools.
